Foreign Student Guarantee of Finances Form

1. Applicant Name

Every student who is not a citizen of the United States must have at least the minimum level of support that AIM requires guaranteed before we can provide you with the needed documents to get your visa. We cannot issue the I-20 you will need to obtain your visa without this guarantee.

2. Conditions For Guarantee

Please carefully read the conditions required by the **Guarantee of Finances form** and it's purpose. If you agree to fully meet these conditions then please sign your name and fill in the information below.

- A. The congregation or individual who signs the Guarantee of Finances Form is making a promise that the applicant will have the minimum amount of monthly and one-time support for the entire time they are in the AIM program. Those who sign the form will be responsible for either making up the difference or helping the applicant to raise the support in the event that some support is lost.
- B. The congregation or individual who signs the Guarantee of Finances Form understands that they will be responsible for bringing the applicant back to their home country should he/she fall below the minimum amount of monthly and/or one-time support required.
- C. The congregation or individual who signs the Guarantee of Finances Form understands the applicant is not allowed to come to AIM without having the minimum support required before they come. They cannot come planning to raise the support they need after they arrive. Your signature is a promise that they do have the support required or they will not be sent.
- D. This form is required for the acceptance process into AIM. However for government purposes the **Guarantee of Finances Letter** is a separate letter written on church or business letterhead stating that you are guaranteeing to the government that the named applicant will have the minimum amount of support required to participate in the Adventures In Missions program. Please make two copies of that letter. Attach one to this form and give the other to the applicant to bring when they come to the US.

I have read and understand the conditions described above and, by signing my name below, am making a promise that the applicant does have at least the minimum support that AIM requires. I further agree that I am responsible for the applicant's financial status and will either bring the student home if their support falls below the minimum or I will see that the money is raised immediately. With this signature I am giving you my word that the applicant will have the minimum funds needed for the entire time they are in the AIM program (in Lubbock as well as on their mission field).
