

WAIVER OF LIABILITY AND HOLD HARMLESS AGREEMENT (AGREEMENT]

My dependent and I understand that exposure to various disease-causing organisms, such as the novel coronavirus, also known as COVID-19, and contaminated objects, as well as personal contact with interested parties, including but not limited to fellow students, instructors, faculty members, staff members, and any other individual(s) employed by or otherwise associated or affiliated with Sunset International Bible Institute (SIBI), the SIBI Foundation (FOUNDATION), and the Sunset church of Christ (SUNSET), these three entities known collectively as the RELEASEES, each located at 3723 34th St. Lubbock, TX 79410, involves a certain degree of risk that could result in illness, permanent disability, or death.

Furthermore, my dependent and I understand the specific hazards of the novel coronavirus (COVID-19) and are familiar with the Centers for Disease Control and Prevention (CDC) guidelines regarding COVID-19. My dependent and I acknowledge and understand that the circumstances regarding COVID-19 are changing daily and that, accordingly, the CDC guidelines are regularly modified and updated. My dependent and I accept full responsibility for familiarizing ourselves continually with the most recent updates.

My dependent and I understand and agree that my dependent's and my participation in Adventures in Missions (AIM) and CampAdventure are our decision based on our understanding of the potential risks involved as a result of COVID-19, and all other disease-causing organisms which may include hospitalization, treatment and/or death. Notwithstanding these risks, which my dependent and I readily acknowledge, we hereby willingly choose to participate voluntarily in AIM and CampAdventure.

By signing below, my dependent and I agree to indemnify, defend, release, and hold harmless the RELEASEES, and their members, officers, Board of Directors, elders, agents, contractors, instructors, staff, and any other individual(s) employed by or otherwise associated or affiliated with the RELEASEES from any and all losses, costs, liabilities, claims, damages, suits, judgments, and expenses of every kind and character, as incurred, resulting from exposure to disease-causing organisms, such as COVID-19, and contaminated objects, as well as personal contact and all other activity associated with my dependent's and my participation in AIM and CampAdventure. My dependent and I also agree to abide by all the guidelines and safety protocols instituted for the safety and health of all the participants we associate with in AIM and CampAdventure.

Furthermore, this AGREEMENT shall be binding upon the undersigned, and his or her respective heirs, executors, administrators, personal representatives, successors and assigns. This AGREEMENT shall be subject to and governed by the laws of the State of Texas.

In signing below, I ACKNOWLEDGE AND REPRESENT THAT I have read the foregoing Waiver of Liability and Hold Harmless Agreement, understand it and sign it voluntarily as my own free act and deed; no oral representations, statements, or inducements, apart from the foregoing written AGREEMENT have been made; I am at least eighteen (18) years of age and fully competent; and I execute this AGREEMENT for full, adequate and complete consideration fully intending to be bound by same. This AGREEMENT contains the entire agreement and understanding between the parties and that the terms of this Agreement are contractual and not merely a recital. This AGREEMENT may not be altered, amended or modified, except by a written document signed by both parties.
